1.0 Opening Business – Solicitor Presiding

- 1.1 Call to Order The meeting of the Hanover Public School District Board of Education was called to order at 6:00 P.M. in the boardroom of the administration building. Troy Wentz read the certificate of election stating that the new board members were duly certified. The newly elected board members were given the oath of office by solicitor, Jim Yingst.

Dr. O'Connor nominated Mr. Smith as the temporary president. Seconded by Mrs. Lingg. Mr. Baker nominated Mr. West as the temporary president. Seconded by Mr. Zeigler. Section 402 provides temporary president shall be elected from among the held-over members. A roll call vote was taken for Mr. West with 9 yes 0 no.

BOARD ACTION:

A roll call vote was taken. The results were four votes for Mr. West and five votes for Dr. O'Connor.

4.0 Fixing Time and Place

Mr. Bortner made a motion to approve the first and third Wednesday at 6:00 P.M. to hold Board Meetings. Seconded by Dr. O'Connor.

Mr. West requested we take time and poll the administrators to see if Wednesday is the best evening for Board Meetings for them. Mr. West made a motion to table until later. Mr. Zeigler seconded the motion. A roll call vote was taken and passed on a roll call vote of 7-2. Dr. O'Connor and Mr. Bortner cast the negative votes.

Mr. Zeigler stated that we need more information especially from administrators. Mr. Baker questioned that when new members ran for school board they knew that Tuesdays were the normal meeting night. Dr. O'Connor stated that Tuesday's are a conflict with some and the board has the right to set the meeting dates. Mr. West indicated conflicting policies on establishing meeting dates; 005 prior to July 1 and 006 at Re-Organization.

There was a motion made by Mr. Bortner to close the debate. Seconded by Dr. O'Connor and passed on a roll call vote of 8-1. Mr. Zeigler cast the negative vote.

There was a motion made by Dr. O'Connor that we have a special meeting on Wednesday, December 19, at 6:00 P.M. Seconded by Mr. Baker and passed on a roll call vote of 5-4. Mr. West, Mr. Zeigler, Mr. Baker and Mr. Kauffman cast the negative votes.
