## F. Superintendent Report - Dr. Scola

- School Performance Profile Dr. Scola will be giving a full report on December 2 where he will let the community know the details. Hanover Street showed a 10% growth. Washington Elementary School scored 90.6% which puts them in the top 10% in Pennsylvania. Clearview Elementary scored 92.9% which puts them in the top 5% in Pennsylvania. There were 12 School Districts in York County who did 90% or better and two of them were Hanover schools. Teachers were extraordinary. There was only one elementary school in the LIU #12 territory who outscored Clearview and that was a school in Central York. We are very proud of them and will celebrate their success.
- Chamber At the Chamber event at the Eichelberger Center we received the Positive Action Award in regard to the metal shop. There were ten business donations which totaled over \$80,000 due to our business partners. There are over 100 students that participate in the classes.
